Explanation of Responses:

- As reported on a Form 4 dated April 30, 2019 and filed on May 2, 2019, the Reporting Person received a grant of 6,153 Restricted Stock Units ("RSUs" or "Units") on April 30, 2019. The RSUs vest as to (a) 33% of the Units granted on the first anniversary of the date of grant, (b) an additional 33% of the Units granted on the second anniversary of the date of grant, and (c) the remaining 34% of the Units granted on the third anniversary of the date of grant. On each vesting date, for each Unit vesting on such date, the Reporting Person will receive one share of Mattel, Inc. Common Stock, subject to tax withholding. On April 30, 2021, the second 33% of these RSUs vested, resulting in the issuance of 2,030 shares of Mattel, Inc. Common Stock.
- Pursuant to the terms of the April 30, 2019 RSU grant, 702 shares of Mattel, Inc. Common Stock were automatically withheld at vesting to cover required tax withholding.
